The Shopper is responsible for providing any insurance coverage's necessary or appropriate to the conduct of the Shopper's business. The Shopper is responsible for payment of any federal, state or other taxes on any fees The Shopper receives for providing any services to and for Service Smart Marketing Ltd. Service Smart Marketing Ltd. will not withhold taxes from any fees payable to The Shopper, but will transmit a 1099 Miscellaneous form to appropriate agencies at the appropriate time.
